My Address to the Assembly: Confronting the Behavior at Hand

I am addressing before you today to speak plainly, honestly, and directly about the behavior that is currently threatening to destroy the foundations of this assembly.

The profound lack of trust running through our community right now does not come from a misunderstanding or an unwillingness to cooperate. It comes from lived experience. It comes from my own observation of individuals attempting to replicate the exact same de facto architectures of control that we crossed the jurisdiction line to escape. I am watching processes being put in place under the guise of administrative order, when the practical effect is nothing more than exclusion, gatekeeping, and the centralized control of a private club.

Confronting the Behavior: Muting and Suppressing Voices

I am addressing a pattern of behavior that must stop immediately. True self-governance requires absolute transparency, yet I am watching private, selective meeting invites dictate assembly business while the general assembly is intentionally excluded. Let me speak from my own experience: I will not tolerate being muted. I have sat in Zoom meetings for this assembly only to be muted by a moderator, stripped of my right to speak. That is not giving a voice to the assembly. When a moderator can arbitrarily silence a living soul, that is not self-governance—it is tyranny by another name.

We can establish decorum, yes. But we have the inherent right to speak how we want, with the passion we choose, as long as it is not a targeted, personal attack. I am passionate about how I speak because I refuse to be passive. I will not sit quietly, and I will never allow anyone in this assembly to speak for me or for my next of kin.

My Proposed Solution: The Master List Voting Procedure

If we actually want to give people a voice instead of silencing them, we must implement real, structural safeguards. We already have a master list of emails in our possession. I am proposing a clear, unalterable procedure right now to fix this broken system:

- Step 1: Whenever an agenda item requires a vote, the proposal must be sent directly to every single email on that master list.
- Step 2: A strict, reasonable deadline must be established for responses.
- Step 3: If individuals fail to respond before that deadline hits, then and only then is a bypass orchestrated to move the assembly forward.

This procedure gives every single person an equal, unblockable opportunity to have their voice counted. It stops moderators from gatekeeping who gets to participate based on who can show up to a specific physical or online meetings.

Dismantling False Claims of Authority

Let me remind you of a fundamental maxim: Fraud vitiates everything. Any meeting, any decision, and any notice issued where the general assembly is shut out or muted is void from its inception. You do not have the authority to decide whose voice is valid, whose information is accepted, or whose participation is 'declined' or 'revoked'.

The living men and women of Nevada are the only government here. There is no 'seated assembly' of career officials, there is no four-year permanent tenure, and there are absolutely no superior power positions. Right now, every single role is a temporary, volunteer position until a full, public, state-wide election is actually held by the people. Show me the voter records or the charts proving otherwise—you cannot, because they do not exist.

Furthermore, I will not stand by and allow dual-citizenship conflicts of interest to dictate our leadership. If an individual maintains active employment within a de facto District Attorney's office, their paperwork automatically disqualifies them from holding office or commanding a militia within this assembly. You cannot serve the corporate de facto matrix and the sovereign living people at the same time.

Conclusion: A Final Warning on Control

I, and the people standing with me, are not creating a 'duplicate assembly,' nor are we engaging in an insurrection. We are simply putting our state hats on and taking back the assembly that a handful of individuals are actively trying to control and dismantle.

The attempts to shut down the domains, hide behind closed doors, and control this body through intimidation have failed. Anna herself has called out these exact control tactics on the coordinator calls.

If we truly wish to help build this assembly, then a fundamental change in behavior is necessary. Stop hiding behind private rules and implement this master list voting procedure so that everyone has an equal opportunity to participate.

My own time right now is heavily dedicated to analyzing and mastering the true infrastructure of the Nevada State operations, meaning I cannot always sit in every physical and or online meeting. But true alignment with the people is not about mere attendance—it is about transparency, shared stewardship, and working with the people instead of trying to rule over them. I will no longer accept a system that claims legality while practicing cold exclusion.
