

The title of Michael trigger Wilson Militia meeting is "Jurisdiction is the Battle Line" at 00:00:08 transcript. Not sure why this title would be used because there is no battle line in jurisdiction or the people in Nevada. Then it goes on at 00:03:00 the is activity going on outside of our jurisdiction. I do not know what activity is going on outside of any jurisdiction in the Nevada Assembly. Then he talks about Clark County functioning as the Nevada Assembly Unincorporated. Clark County or the Union State has never declared their self's as the Nevada Assembly. He goes on at 00:04:19 to talk about a seated assembly and we are the sovereign union state with elected officials and the vetted assembled people of Nevada. He needs to know that the people of Nevada is the only government and we do not have seated officials only volunteer people in Nevada. The other thing Michael Trigger Wilson does not understand the assembly changes and grows as it needs to. He goes on with the name Sue, Doug, and Jennifer Olsen and they do not represent the assembly ever. He states that they are advisory and temporary, not governing. This is true and the people with their standing as Nevada Assembly people are standing up and building their assembly as they want.

At 00:45:48 he says, "the faction that's declaring themselves an independent state believes the Federation runs Nevada". At no time do the people in Nevada believe the Federation runs anything in Nevada. Also, Nevada is not a freestanding sovereign union state. It may be a Union State and a State of the Union.

At 00:06:23 he finally states the truth that the authority runs from the people but not to the elected assembly. No such thing as an elected assembly. We all need to release that the people are the only thing that sits above the assembly. He goes on to threaten the people in Nevada on 00:06:40 in the transcript by saying "So the folks that are calling themselves the Nevada Assembly Unincorporated are making a big mistake". At 00:07:40 in the transcript he says that the "Federation appointed coordinator is claiming state authority". At no time did Tamara Ameral claim any such thing. She just stood up as a State Coordinator to chair the meeting the people requested. She is not a installed by a faction vote without Sue. Sue is not the one that picks coordinators or removes coordinators. This is done by Anna. The other thing Michael needs to be trained on is there was a time when the state was able to vet coordinators because the Federation did not have the manpower to do so. Now that the Continental Marshals can vet their jurisdiction people are doing so.

At 00:08:08 in the transcript Michael Trigger Wilson states there was a meeting in Clark County and there was and it was online for the people in the rest of the state could be in the state portion of the meeting. An email went out to everyone in Nevada to inform them of the meeting and they need to attend the meeting to make their voices heard. This would be done n the other state assembly meeting, but a lot of the people are not allowed in the meeting to make their voices heard. At 00:08:38 in the transcript Michael Trigger Wilson made a commit that he does not remember anybody coming forward in the Nevada Assembly meeting to become a coordinator and go through our

state vetting. Again, I do not know where he has been but, Tamara Amaral had asked Sue in one of the meetings to be able to get in Lisa's coordinator training and Sue helped her get into the training. On that to that coordinators again do not go through the state to be voted on or vetted for the Federation position. On 00:08:56 in the transcript he states that the coordinators don't have any authority of any kind and that is true not even Sue, Rockie, or Tamara.

At 00:09:13 in the transcript he states that Continental Marshals vetting has always been a secondary vetting process. I do not know where he has been but from 2021 when I came into the assembly they did all vetting for coordinators. The reason they stopped, and the states did it for a while is they did not have the staff to do it. Now they do and Anna and the Continental Marshals sent out a mandate that all coordinators needed to be vetting again by the Continental Marshals again.

On 00:09:23 in the transcript he states the coordinator is always for international work. That is far from the truth. Coordinators are Federation liaisons to the state to help build the state up. There jurisdiction is in the international or Land and Air jurisdiction. Then he goes on at 00:09:46 in the transcript that Terri Sham and Anna agreed that the states would do the vetting. At one time as said above that was true because the Continental Marshals did not have the manpower to do so. And again, we need to pay attention on how people talk and what they say. It was implied the Teri Sham run a Land Recording Office and leaves it open so you would think it is a Federation Land Recording office. Anna has stated many times that every State needs to have their own Land Recording Office and software. She just said it again in the coordinator call on 6-18-2026.

On 00:10:17 in the transcript he says that the people by a raise of had declared we are the Nevada Assembly. That is far from the truth. What was said is that everyone in Nevada that has done their papers work is the Nevada Assembly if they are wearing the hat as a state man or woman. This is where Michael Trigger Wilson need training on is it is everyone in the State that makes up the Nevada Assembly. Not the 4 or 7 people up north in Nevada.

On 00:10:32 in the transcript Michael Trigger Wilson says that Tamara's own State Coordinator in her first meeting with no established vetting no record mandate is now the Nevada Assembly Unincorporated declared its own courts and offices ready and plans to notice the de facto. Again, far from the truth. Clark County has done their election and has their offices ready and will notice the de facto when needed. This has nothing to do with the Nevada Assembly

On 00:11:03 in the transcript Micael talks about the coordinator call where Anna praised Rockie on a brilliant move. She has told Rockie and the rest of the people in the coordinator calls that the people in the states and their counties are the same people. On 00:12:44 in the transcript he said the motion against Mike, Me, got no recorded vote count. He is right because everyone agreed to talk about it in the next meeting. So, it will be on the topic in the next

Nevada Assembly meeting. He then says there were only a dozen thumbprints on his notice to stop trying to represent the Nevada Assembly. As you know 2 or more signatures are better than a notary signing.

On 00:13:29 in the transcript Michael states that on May 30 of 2025 there was an election and he was voted in for a four-year term. The people of Nevada do not remember any public election of any officials in the Nevada Assembly for any office. Right now, the assembly is not standing and has not made any public elections for the state. Right now, everyone is volunteering to hold positions until an election for officers can be held. At no time has anyone seen any chart or document stating any position that has been voted in the Nevada Assembly. Please show proof of any votes.

On 00:14:18 in the transcript Makes a commit on that in a notice he was asked to get more training before he could become the Militia commander and his paperwork disqualifies him. What the notice states is that Michael works at the District Attorney's office which disqualifies him for the office. Dual citizens can't take any offices in the assembly.

On 00:14:54 in the transcript he states that the people in the assembly has no jurisdiction or standing over a seat or seated assembly elected man or woman. Again, Michael needs training on how our assembly is run and who has the jurisdiction over its assembly officers. The people that have done their paperwork and live in Nevada have all the standing and jurisdiction to election and remove anyone in a office in the assembly.

On 00:15:16 in the transcript Michael states the Nevada Assembly is well established like this make what is going on that no one can change it. Remember anything that is been done can be undone be the people established or not.

On 00:15:51 in the transcript Michael states that authority to constitute an assembly derives from established process, vetting, recording, election not from a single meeting's enthusiasm. Again, training is required before Michael goes on any more on what establishes an assembly. If he was around long enough the assemblies were created by a few people in the state. It is the people that determine the assembly. There was no process, vetting, recording, or election to create and run an assembly. Again, what has been done can be undone by the people. (Nevada Assembly)

On 00:16:37 in the transcript says that the people have no impact and has no effect on the Nevada Assembly. Who does he think has any effect or impact on the Nevada Assembly. It is only the people in the state that have any impact or effect on the Nevada Assembly. As you read through the highlighted parts after that he states the is no mandate, no standing, no electoral mandate from the people on Nevada. On 00:18:12 in the transcript Michael state that Tamara is appointed by the Federation as a coordinator and says Ok, big whoop. Well, you can say that for all coordinators in Nevada and yes you do not have to except any of them and that goes for the rest on the people in Nevada. They do not except what ever is going on right now with Sue, Doug, and You. You are right you can reject anything that a coordinator

On 00:31:30 in the transcript you talk about someone coaching Rockie on how to be a coordinator in the model county meeting. The people would like to see that because Rockie was already a coordinator when he was in the model county meetings.

On 00:32:14 in the transcript you talk about Rockie co-author a county handbook. Again, if you all were on the coordinator calls Anna assigned the development of the “How to build a county/union state guide” and was ask by Anna to include Louise in the process. Yes, All the counties and assemblies will be using this guide to help them build their assemblies. No different then everyone using the “How to build an Assembly” guide. You all would think it is great that Anna has chosen someone in Nevada to write the guide or handbook.

On 00:33:00 in the transcript Michael goes on to say we always welcome help when we ask for it except if you are meddling in internal assembly matter is declined and documented and offer assistance and we may accept it and assert authority and we invoke. This is the proof you all are trying to control what is going on in the assembly. Who gave you the authority to only except what you want and decline or revoke the information or people.
